eToro Options

Securities are offered through eToro USA Securities Inc. ("eToro"), a registered broker-dealer and member [FINRA](#) and [SIPC](#). "eToro Options" is a product name used to refer to the options trading platform provided by eToro USA Securities Inc. eToro USA Securities Inc.

For international (non-US) clients, there is an options contract fee of \$.50 per contract. International (non-US) clients are also subjected to other fees outlined within this schedule.

eToro Options International Transfer Fees

Your eToro Options account is based in USD and cash in that account is held in an FDIC member US bank available through eToro's [Clearing Broker's cash sweep program](#). If you have a non-US bank account, an international wire will be required to fund or withdraw from your account

Regulatory Trading Fees

While eToro does not charge commissions on self-directed trades on US equities and options contracts, nominal SEC & FINRA regulatory fees do apply to certain transactions. Specifically,

options incur an Options Regulatory Fee (ORF), and sales of securities incur a Trading Activity Fee (TAF) and Securities and Exchange Commission (SEC) fee, which are passed on to the customer.

eToro Options High Interest Program Fees

eToro customers with an eToro Options account, which is specifically designed for options trading, can earn interest on the cash held within that account. To participate in this program, customers must opt in through eToro, with Apex Clearing Corporation acting as the clearing broker-dealer. Apex charges eToro a \$2/month fee for any account enrolled in the program that has a cash balance at any point during the month. eToro will pass this \$2/month fee to customers enrolled in the program. However, if a customer maintains a combined asset balance of \$5,000 or more (including investments and cash) across their eToro Options account and other eToro or affiliate accounts (such as stocks, ETF, cryptocurrencies, or other cash holdings), eToro will waive the \$2/month fee. For customers who do incur the fee, the \$2/month will be automatically debited from the cash in their eToro Options account each month. Customers can opt out of the program at any time by contacting [Customer Service](#).

Currently, interest can only be earned on cash held in eToro Options accounts, and brokerage accounts in certain jurisdictions (Hawaii, Nevada, New York, Puerto Rico, and U.S. Virgin Islands). However, eToro and its affiliates are working towards offering interest on cash held in other types of accounts in the future, depending on service provider availability.
